# **London Living Wage**

In November, **Islington Council** became the <u>first to be awarded 'Friendly Funder' status</u> by the Living Wage Foundation and Citizens UK. This means that charities and voluntary organisations will only receive funding from the council's core grants programme if they pay a Living Wage.

The **Resolution Foundation** is trying to <u>clear up confusion</u> between the government's 'national living wage', to be introduced in April, and the Living Wage.

The new not-for-profit campaigning organisation **Living Staff Living Wage** is holding a <u>launch and fundraising event</u> on the 6 February from 6 - 11pm. LSLW is made up of activists from the initial Ritzy cinema workers campaign for a living wage.
